

Online Filing of the Personal Income Tax Return by an Accredited Person

This form is for use by any individual who has his or her personal income tax return filed online by an accredited person (hereinafter "preparer"). The individual must provide the preparer with a copy of this form to confirm that the information transmitted on the individual's behalf is accurate and fully discloses all of his or her income.

The individual must **complete and sign** two copies of this form. The preparer identified below and the individual must each keep a copy for at least six years after the end of the taxation year covered by this form.

I understand that if my return is rejected on transmission, the above-mentioned preparer may amend and retransmit it without a new TP-1000.TE-V form being filed, provided the changes result in a difference of less than \$300 on line 470 and have no effect on amounts transferred to my spouse, if applicable.

I understand that, on gaining access to my netfiled tax data, Revenu Québec becomes responsible for ensuring its confidentiality.

I certify that the above information is accurate and complete, and fully discloses all of my income. If I have entered an amount on line 123, it is because I elected to add to my income a portion of my spouse's retirement income.
